



## Declaration of Substances of Very High Concern (REACH)

12.04.2023

To whom it may concern,

According to Article 33 of the Regulation (EC) No 1907/2006 on the Registration, Evaluation, Authorisation and restrictions of Chemicals (REACH), the Christoph Miethke GmbH & Co.KG (MIETHKE) has the duty to communicate the presence of substances of very high concern (SVHC) as provided by our suppliers to their customers. The current list of SVHC (candidate list) is published in article 59 of the REACH regulation and can be found on <a href="https://echa.europa.eu/de/candidate-list-table">https://echa.europa.eu/de/candidate-list-table</a>.

MIETHKE is a downstream user and does not import quantities of more than 10 tons per year of substances of very high concern. Therefore, there exists no registration obligations for MIETHKE.
